SUMMARY:

The City of Edgewater issued Invitation to Bid (ITB 25-ES-01) on March 17, 2025 with the sole purpose and intent of obtaining bids from qualified and licensed contractors for the ITB 25-ES-01 Park Ave. Booster Station Rehab and Demo. This project is funded by the Florida Department of Environmental Protection State Revolving Fund Program.

This Solicitation was broadcast via the City's E-Procurement Platform, as well as via DemandStar, Beacon Bid, and the State of Florida DMS, Office of Supplier Diversity site, published in the Daytona Beach News Journal, and posted in City Hall.

On April 30, 2025, eight (8) bids were submitted and 2 no-bids were received. All eight (8) bids were deemed responsive and responsible
