Notice of Recommendation

RFQ 24-DS-07 Professional Surveyor Services Date: July 8, 2024

SUMMARY:

The City of Edgewater issued a Request for Qualifications (RFQ 24-DS-07) on May 2, 2024 with the sole purpose and intent of obtaining Qualifications from interested companies to render Professional Surveyor Services.

Ten (10) submittals were received and all were deemed to be responsible/responsive responders. On June 27, 2024, the Evaluation Committee met and discussed the submittals based on the criteria listed in the RFQ The Committee ranked the proposals as follows (Bid Tabulation and Distance Calculations document. attached):

The Committee determined it would be most advantageous to the City to recommend multiple firms be awarded contracts and agreed that six (6) firms would be recommended. They further discussed the possibility of asking the firms to come in for presentations, however the Committee concluded unanimously that there were enough clear top-ranking firms identified by review of the written submittals alone and therefore declined requesting presentations. Engagement of firms will be on an as needed basis and based on the City's needs with consideration to submitted firm's availability and capabilities.

Description:

The form of business of the prime consultant, i.e., proprietorship, partnership, corporation; years in business; changes in ownership; bank reference; and any other information the applicant may wish to supply to verify financial responsibility. Include the most recent audit, bank reference or accounting summary or other information that illustrates Financial Responsibility for the firm, and current certificate of insurance.

Description:

Location of the consultant's home office (corporate headquarters) and location of the local office where the project(s) will be produced. The members of the project teams should be permanently assigned to the project office. Routine and responsive face-to-face interaction will be important in servicing the City's needs in performing this continuing contract. In the event a team member is relocated, another team member with equal or better experience and qualifications shall be substituted. Team members shall not be transferred, relocated or reassigned while performing work on a specific City project without prior approval of the Development Services Director.

The following scale will be used based on the address for the local office where project(s) will be produced:

Within City Limits of Edgewater - 10 points

within 25 miles of base - 8 points

25-50 miles from base - 5 points

50-100 miles from base - 2 points

over 100 miles from base - 0 points
