#### **Background:**

2798 S Ridgewood Ave is a Dollar General store. On 5/13/2025, Dominick, the Manager of the Dollar General, spoke with Code Enforcement about their dumpster being damaged. Officer McGlothlin met with Dominick, who showed him the dumpster. The dumpster enclosure gates were broken at the hinges and did not close properly. The gates either needed to be replaced or properly repaired so that the employees at Dollar General can effectively close the dumpster enclosure. Dominick also pointed out that there was overgrown vegetation extending into the parking lot, which Officer McGlothlin confirmed. Both the dumpster enclosure and the overgrown vegetation fall under Sec. 10-500 Minimum standards. The property had a Notice of Violation issued on 1/15/2025 for the same violation. As the violation is reoccurring, a citation was issued on 5/13/2025.

All notices and provisions of Chapter 10 Article XXVII have been complied with.

#### **Staff Recommendation:**

Staff recommends that the violation receives a \$75 citation in accordance with Section 1-8 (General Penalty; Continuing Violations).


