# 4. NEW BUSINESS - PUBLIC HEARING

a. 2nd Reading - Ordinance No. 2024-O-04 - Request for a large-scale comprehensive plan amendment to update Chapter 4 Stormwater Sub-Element of the City of Edgewater's Comprehensive Plan

c. SD-2302: Request for Preliminary Plat approval for Smyrna Creek Preserve, a 78-unit townhome subdivision found generally located West of Old Mission Road.

d. CPA-2301: Request for a small-scale comprehensive plan amendment from High Density Residential, Commercial, and Low Density Residential to Mixed-Use with Conservation Overlay for parcels generally located East of S Ridgewood Avenue and North of Jones Fish Camp Road.

Mr. Solstice provided a staff report and recommendation.

Chairman Kennedy opened the public hearing.

Ralph Richardson, expressed concerns regarding the 10' landscape buffer in relation to his property.

Marilyn Bennett 194 Jones Fish Camp Road, spoke of her concerns of the increased traffic, and the current condition of the road & drainage issues.

Daniel Lewis of 100 Lewis Street, Representing Susan Kahn and Creative Pathways Preparatory Academy, spoke of concerns of traffic, noise, and safety.

Ken Peacock of 133 Jones Fish Camp Road, wanted to know when the development would begin and how two eagles nests would be handled.

Pamela Hahn, 133 Jones Fish Camp Road, expressed concerns of what access road will be utilized for construction purposes, the mosquito ditch behind her home, and the dry dock boat storage.

Mark Watts, attorney with Cobb-Cole addressed all the concerns mentioned above.

There being no further discussion Chairman Kennedy Closed the public hearing.

e. RZ-2301: Request to rezone the property from City of Edgewater Residential Planned Unit Development (RPUD) and Highway Commercial (B-3) to City of Edgewater Mixed-Use Planned Unit Development (MUPUD) for property generally located East of S Ridgewood Avenue and North of Jones Fish Camp Road.

Mr. Solstice provided a staff report and recommendation.

Chairman Kennedy opened the public hearing.

Ralph Richardson restated his concerns regarding the 10' landscape buffer and water retention.

Ken Peacock, 133 Jones Fish Camp Road restated his concerns regarding the mosquito ditch, road usage, and drainage/flooding, and river access.

Marilyn Bennett, 194 Jones Fish Camp Road, restated her concerns of the increased traffic and what road is going to be used for construction.

Mark Watts attorney with Cobb-Cole addressed all the concerns mentioned above.

There being no further discussion Chairman Kennedy closed the public hearing.
