

RESOLUTION #CRA-2026-02

**A RESOLUTION OF THE EDGEWATER, COMMUNITY
REDEVELOPMENT AGENCY, EDGEWATER, FLORIDA;
ADOPTING BUDGET AMENDMENT FOR THE FISCAL
YEAR 2025 – 2026 AND PROVIDING AN EFFECTIVE
DATE.**

WHEREAS, in 2025 the Edgewater Community Redevelopment Agency (Edgewater CRA) adopted an operating budget for Fiscal Year 2025-2026 pursuant to Resolution No. 2025-CRA-01; and,

WHEREAS, during the July 6, 2026 City Council meeting, Council verbally approved a mid-year budget amendment to the CRA Budget.

WHEREAS, the Edgewater CRA budget amendment is reallocating \$140,000 from façade grants to Land Acquisition pursuant to itemizations contained in Exhibit “A” which are attached hereto and incorporated herein; and,

WHEREAS, the budget amendments allow the City of Edgewater Community Redevelopment Agency (Edgewater CRA) to adjust the Fiscal Year 2025-2026 budget;

NOW, THEREFORE, be it resolved by the Community Redevelopment Agency of the City of Edgewater, Florida as follows:

Section 1. Authority. The Edgewater CRA has the authority to adopt this Resolution pursuant to the Special District Act.

Section 2. July 2026 Budget Adjustment. The governing body of the Edgewater CRA amends the Fiscal Year 2025-2026 budget by revising the budget in total pursuant to itemizations contained in Exhibit “A” which is attached hereto and incorporated herein

Section 3. Effective Date. This resolution shall take effect upon adoption.
